4. Windhoek City Police

Chief Rich introduced Retired Deputy Chief Constable Rick Lucy. Mr. Lucy has been the key liaison with the Windhoek City Police Services (WCPS) for the APD. Since his retirement he has become an Advisor to the WCPS. Mr. Lucy reviewed:
