The meeting was called to order at 1200hrs by Aman Gill, Acting Chair.

1. Adoption Of Agenda

2. Welcome of New Police Board member Christopher Dominato

Mr. Dominato was welcomed to the Board and introductions were made.

4. Business Arising Out of Previous Minutes

5. Chief's Report

A/C/Cst. Serr reported on Project Abby Sweep, targeting prolific property offenders, noting that over the four week duration of the project 59 arrests were made, 39 new charges, and three stolen vehicles recovered. Meetings have occurred with Crown Counsel to identify ways to tighten the bail and release conditions and keep prolific offenders in custody.

D/C/Cst. Freill reported on recruiting initiatives noting that the 2018 goal is for 25 new hires and that by the end of May there should be 14 in place. The aggressive recruiting is largely due to being behind with succession planning due to retirements. Other initiatives to assist in recruiting are:

- information session on APD recruiting taking place at the MCA
- recruiting postcards are being handed out strategically
- two sessions in July and August are scheduled for interested applicants to meet the APD Recruiters
- previously deferred applicants are being revisited
- advertising with the military

A/C/Cst. Serr noted that the Traffic unit will be fully staffed at five and one and the Gang unit to three and one.

A/C/Cst. Serr noted that there are two bike members working on homelessness issues.

A/C/Cst. Serr provided an update on the West Abbotsford Youth Action Group (WAYAG). By the end of March it is anticipated that there will be 17 mentors identified for pairing with prescreened candidates. There is a registered clinical counselor who will teach skill building for families and youths being mentored. A summer program is being worked on that will include sports, music, and arts. There is also a Parent forum being organized.

A/C/Cst. Serr reported on the 2nd Coffee with Cop that took place March 9th. The events have been successful amongst the community, with 100 plus citizens attending the last session. At this event youth and school teachers from five middle schools delivered 300 cupcakes as a symbol of thanks to the APD. There is another event schedule for West Abbotsford and there are plans to host Chai with Cop.

6. Update on National Summit on Gun and Gang Violence

Yvon Dandurand attended the National Summit on Gun and Gang Violence in early March which was attended by government, law enforcement, academia, community organizations, and Mayors in an effort to learn about and tackle gun and gang

violence. Best practices were shared at the Summit along with the challenges that law enforcement is faced with in dealing with this growing problem. Funding, to best tackle these issues, is one of the most significant challenges. The need for strong cooperation amongst law enforcement agencies was a topic of discussion at the summit. It was noted that the standard gang disruptive techniques/activities has proven to cause more violence and displacement is not a sustainable solution to this problem.

An announcement regarding funding is expecting in the coming weeks.

The proceedings of the summit will be made available and will be circulated to the Board.

7. BCAPB

Aman Gill reported that the next meeting is in April at the conference.

The co-hosting, between Abbotsford and Port Moody, of the 2019 BCAPB Conference and AGM in Harrison was discussed. It was noted that the roles and responsibilities between the two agencies would need to be clearly organized and established early on. A/C/Cst. Serr noted that Port Moody Police Department/Board is committed to co-host.

MOTION: That the recommendation for the Abbotsford Police Board to cohost, with the Port Moody Police Board, the 2019 BCAPB Conference and AGM in Harrison be approved.
