II.B.120	Missing Persons

## **PURPOSE**

- (1) To establish an overall approach to be taken in Missing Person investigations by the Abbotsford Police Department ("AbbyPD").
- (2) To ensure that all Missing Person investigations are prioritized and undertaken at a high standard appropriate to identified risks.

## **DEFINITIONS**

- (3) **Missing Person** –anyone reported to police or by police as someone whose whereabouts are unknown, whatever the circumstances of their disappearance, and who are considered missing until located.
- (4) **Reportee** the individual making a report of a Missing Person to the police.

## **POLICY**

- (5) AbbyPD Missing Persons investigations will be guided by the principles laid out in section "PRINCIPLES".
- (6) AbbyPD Missing Persons investigations will be conducted in compliance with AbbyPD Standard Operating Procedure SOP 20-01 Missing Persons, BC Provincial Policing Standards with respect to Missing Persons, and all relevant legislation.

## **PRINCIPLES**

- (7) There should be no barriers to reporting a Missing Person and investigations should begin without delay. All Missing Person reports made to the AbbyPD are accepted.
- (8) Investigations into persons reported missing should initially be approached as high risk until a risk assessment is completed. A member will conduct a risk assessment without delay and, in consultation with a supervisor, determine

- the resources to be applied, the urgency with which to apply them, and possible lines of enquiry.
- (9) If foul play is suspected, the case must be assigned to the Major Crime Unit ("MCU").
- (10) The safety and wellbeing of the Missing Person is the primary concern driving investigative tasks and decisions. Finding the Missing Person safe and well is the paramount objective.
- (11) Members will use discretion to address the unique needs of each case, with accountability for decisions through supervisory review.
- (12) Cooperation between police agencies is crucial to Missing Person investigations. AbbyPD's designated Missing Person Investigator assists in supporting open communication and cooperation on cases crossing jurisdictional boundaries.
- (13) Families and Reportees will be kept appropriately informed of the progress of an investigation.
- (14) The right to privacy must be balanced with police responsibility to ensure the safety and wellbeing of a Missing Person. Assigned police investigators must assess whether the Reportee may be inappropriately using the police to locate a person who does not want to have contact with the Reportee.
